

U.S. EPA Region III Stakeholder Meeting

- Testing Strategy follows MAMF-2017
- 100% testing of occupied ground contact units.
- 10% of upper floors.
- Large open areas, one kit per 2,000 SF







U.S. EPA Region III Stakeholder Meeting

- Three-year plan, 2022 thru 2024
- Projected to deploy 817 test kits over three years.
- To date 513 test kits deployed at two campuses.







U.S. EPA Region III Stakeholder Meeting

- Test results breakdown:
 - 351 (68%) <= to 4 pCi/L
 - 64 (12%) >4 <10 pCi/L
 - 28 (5%) >= 10 pCi/L
 - 59 duplicates
 - 11 tampered with

Lancaster Co. Retirement Complex

Retirement Community State-wide Rn. Data

- Less than 4 pCi/L- 79% Less than 4 pCi/L- 62%
- 4 to 10 pCi/L- 14% 4 to 10 pCi/L- 23%
- > 10 pCi/L- 6% >10 pCi/L- 15%




Special stainless-steel brackets, custom fabricated.






