FY25 Budget and SIRG

- State Indoor Radon Grant (SIRG) for FY25 ~ \$9.1M
- Decrease of ~ \$12K in funding levels from 2024
- .4% increase in regional funding (\$4,000)

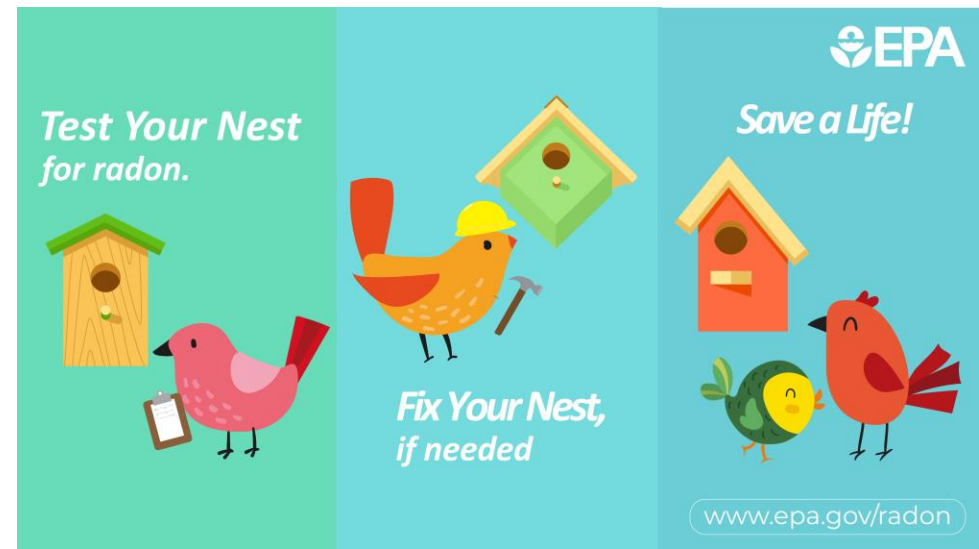
- West Virginia experienced an increase in radon awareness statewide with over 1,000 free test kits requested and distributed during FY24. This increase in awareness stemmed from the state partnering with local county health departments to provide free test kits
- In Pennsylvania, 115 schools/daycares were tested, and two (2) schools were mitigated for radon. In addition, hospitals participated in the PA “Newborn Program” that provides new families with a copy of the *New Parent's Citizens Guide to Radon* booklet and a free radon test kit.

Regional Highlights

- R3 worked with HQ to finalize and publish the updated [SIRG Program Handbook](#) that outlines EPA's SIRG authorities, relevant regulations, eligibility requirements and more.
 - Successful 2025 National Radon Action Month
 - Will be able to fully fund all the SIRG grants through 9/30/2026
 - Sydney Stern will assist with SIRG and radon outreach.
