

Indiana Radon Updates

## Radon Reporting Portal

### Improvement to Data Entry

- Adjusting parameters to allow more consistent data entry
- Ensure that data is reported through selection of specific options
- Data refinement to ensure accurate reporting and useability

### Challenges

- Office of Technology limits on Out-of-State IP addresses
- Contractors who were licensed but had no systems/testing still need to report 'No work performed'
  - New licensees who acquire late in the year still need to report

Measurement/ Mitigation Reporting


2024: 52%

2025: 71%



### **Radon Dashboard**

- Collaboration with the Office Data and Analytics will create a radon dashboard for the citizens of Indiana
- Location of measurement and mitigation specialists
- Average of radon testing results throughout the state as well as within each county
- Projected launch in mid 2026





### AARST QA/QC

#### FY25 marks the start of round five

- Homeowner agreement continues to be a challenge (18%, increase from 15%)
- Majority of non-compliance on systems was informational (labeling), not functionality
- Little more than half the systems needed labeling corrections
- Manometer marking was next common issue (20%)
- Only 1 out of 25 measurement audits had a major deficiency (No QAP)

In 2023, the Indiana Department of Health (IDOH) partnered with EPA to inspect a random selection of radon mitigation systems in Indiana under 410 IAC 5.1-1-29(d). The program seeks to improve the overall quality of Indiana radon professionals by identifying possible installation issues regarding both requirements and best practices as identified in ANSI/AARST SGM-SF-2023. In 2023, Andreas Johnson (RTM01279) installed a radon mitigation system at 3038 Stilton Drive, Cicero, Indiana 46034. The following minor issue was identified:

 Label for radon systems where owner/occupant maintains the system includes notice of state/federal radon resources. Note - There is a QR code with an indication to scan for more information.

While the listed **minor issue** is not required to be corrected at this time, they do not meet the regulatory requirements for radon mitigation installation. Please contact your installer to correct all issues.





## **Radon Metrics**

2024	Goal	Metric
34,120	30,000	Number of addresses tested for radon
23.4%	23.3%	Percentage of homes that test at or above the acceptable level of radon (4.0 pCi/L).
<mark>17.5</mark> %	44.3%	Percentage of homes that test at or above the acceptable level of radon (4.0 pCi/L) and receive mitigation.
